

Minutes Montana Board of Regents July 15th, 2021

Thursday, July 15th

Meeting convened at 8:30am

Regents Present: Casey Lozar, Chair; Bob Nystuen; Brianne Rogers; Joyce Dombrouski, Todd Buchanan, Loren Bough, and Amy Sexton. Ex officio members included: Commissioner of Higher Education Clayton Christian; Governor Greg Gianforte, represented by Dylan Klapmeier, and Superintendent Elsie Arntzen.

Welcome and Comments by Chair Lozar

Chair Lozar welcomed all attendees and thanked those for traveling to Helena for the summer business meeting and session. Chair Lozar extended congratulations to Regent Sexton as being reappointed by Governor Gianforte as a repeat student regent. He also recognized Regent Sexton's unique tenure on the board as being primarily virtual and is looking forward to the meetings post-pandemic. Chair Lozar briefly reviewed the meeting agenda items and topics of discussion.

Approval of Minutes

• May 26-27, 2021 Meeting Minutes

A motion for approval of May 26-27, 2021 Minutes was made by Regent Rogers; motion passed (7-0).

Commissioner's Report

Commissioner Christian extended thanks to all the board members for their attendance at this meeting. He commended the board's efforts to travel across the state and their hard work and dedication over the challenging past year.

Fall Return to Campus

Commissioner Christian spoke to the hard work campuses are putting forth in preparation for the fall semester and their excitement to have students back on campus again. As discussed in May, the plan is for a relatively normal fall semester. He acknowledged the challenging year it has been for campuses. There will still be a need for precautions as we navigate this new normal. These precautions will include providing remote access for students, as well as testing and quarantining. He explained that vaccines would play a role in this fall's return based on current medical advice. He has asked campuses to encourage and incentivize students to get vaccinated by readily available and easily accessible vaccines.

Preview of September Board Meeting

Commissioner Christian explained a return to normal for this Board as well. Therefore, the plan is to have the September Board Meeting back on campus. Board members have expressed the importance of connecting with students, faculty and staff, and the community on campus. This meeting will be in Butte, MT, at Montana Tech on September 15-16th.

Commissioner Christian announced Jasmine Casanovas as a new addition to the Commissioner's team. She will be filling the role of Executive Assistant to this Board and the Commissioner. He further announced that Amy Unsworth has taken on a new role in Student Assistance. He extended further gratitude to Jasmine, Marlys, Jared, and Edwina for their efforts to help make virtual board meetings a success.

Helen Thigpen, Executive Director of Government Relations & Public Affairs, provided an update on compensation for student-athletes. This update included a description of two significant components around this issue. The NCAA's education-related benefits for student-athletes was previously capped for items like tuition, room and board, and books. A recent decision by the US supreme court struck down the limits by indicating that the NCAA had violated antitrust rules by setting a nationwide limit on education-related expenses. Ms. Thigpen provided additional information regarding compensation that an athlete may receive for use of the student's name, image, or likeness (NIL). On July 1st, the NCAA adopted an interim rule to allow student-athletes to be compensated for their NIL in certain cases. Ms. Thigpen stated that the System is focused on providing/supporting training for student-athletes on these issues. She noted that payto-play activities remain prohibited. Campuses are currently preparing and creating policy for implementing these changes prior to athletics beginning this fall. Discussion followed.

Helen Thigpen, Executive Director of Government Relations & Public Affairs, updated the Board on the American Rescue Plan Act (ARPA) that Congress passed last March. She also discussed House Bill 632, passed by the legislature last session. Ms. Thigpen described the components of House Bill 632 and noted that Ron Muffick at OCHE has been working on the infrastructure commissions by preparing submissions for water and sewer projects. Ms. Thigpen further described the three proposals submitted to the economic workforce commission by OCHE. Discussion followed.

Remarks by Governor Gianforte (or Designee)

Mr. Dylan Klapmeier, Governor Gianforte's Education & Workforce Policy Advisor, provided a brief update on behalf of Governor Gianforte. Mr. Klapmeier congratulated Regent Sexton on her reappointment to the Board of Regents. Mr. Klapmeier spoke to the recent meetings and discussions for the upcoming Board of Education, chaired by the Governor. Mr. Klapmeier spoke to a recent meeting between Governor Gianforte

and Commission Christian, where the Governor discussed four priorities, he would like the University System to pursue 1. underlying costs of higher education at universities in Montana 2. graduation rates 3. innovation 4. public private partnerships. Mr. Klapmeier expressed gratitude for the partnership established with the Office of the Commissioner of Higher Education staff. He further noted that at the Education Interim Committee Meetings the day before, they discussed several items of interest to the Governor's office. These included HB 403, HB 279, career and technology education, school choice and instructional innovation, HB 47, and underlying costs of higher education. Discussion followed.


