Policy 303.1 – Academic Program Proposals

Adopted: October 19, 1973; Revised: March 4, 2016; Revised November 22, 2019

I. Board policy:

- A. The commissioner of higher education shall establish a process whereby institutions of the Montana University System may propose new postsecondary educational program offerings or modifications to existing offerings.
- B. The board of regents will monitor all such academic proposals through notification or request for approval at regular meetings of the board. The commissioner shall determine the level of review and/or action necessary for each item.
- C. Additional details concerning the academic proposal process established by the commissioner of higher education, including required documentation, will be made available by the commissioner via the Montana University System website.
- D. When developing academic proposals, all institutions are encouraged to collaborate rather than duplicate existing programmatic offerings. Unnecessary duplication will be taken in to consideration by the commissioner of higher education and the board of regents when evaluating proposals.
- E. In all instances, the board of regents may request additional information or require a report from outside consultants to analyze the proposal.
- F. When considering program proposals, the commissioner and board may consider, among other criteria, whether: i. The proposed program aligns with the MUS strategic plan, the campus mission, and the campus mission parameters as defined in BOR Policy 219.1. ii. The proposed program demonstrates convincing evidence of student demand, employer demand, or societal need. iii. The proposed program avoids unnecessarily duplication and cannot be delivered more efficiently through collaboration or alternative arrangements. iv. The projected benefits to the state outweigh the costs of the proposed program. v. The institution has the capacity to deliver the proposed program to an acceptable degree of quality with existing and projected resources.

II. Review of new academic programs

- A. The commissioner of higher education shall establish a process whereby newly approved academic programs will be reviewed. The commissioner shall determine the level of review necessary for each such program.
- B. The commissioner shall determine thresholds for adequate enrollment in newly approved academic programs. Programs failing to meet these thresholds shall either develop an action plan for improvement for review and approval by the board of regents or shall be placed into moratorium. The commissioner shall set what level of performance corresponds with each sanction.
